Your letter received on even date at 11h05AM refers.

It is with the utmost of surprise that we note the content thereof.

It is abundantly clear that as per the content of your correspondence that you are in possession of no supporting documentation that supports your version that our client is in any way, form or manner connected to the list of Headers contained in the paste bin link as was provided by you to our client.

In this regard we formally record that your actions led to the following:

1. That our client's account with Transunion has been suspended pending a formal investigation to be launched.
2. That our client has suffered substantial damages by virtue of clients having cancelled agreements with our clients as a result of the unfounded allegations as made by you in the published media.
3. In this instance it is common cause that you have listed our client as the subject matter in your published article without having any founding documents to support such submissions made.

In this instance we formally record that should we not receive an unequivocal and unconditional retraction to be published by no later than the 19th of October 2017 we will proceed with immediate steps in litigation against you having regard for your unlawful actions as undertaken herein.

Such litigation will not be limited to a possible Interdict to be obtained but will also include a substantial damages suit to be instituted against you having regard for the said unlawful actions undertaken herein.

Kindly take note that we wish to receive your retraction by no later than 08h00 on the 19th instant in order to ensure that the content thereof is to the satisfaction of our client and as stated hereinabove should same not be forthcoming we hold instructions to proceed with immediate further steps in litigation.

We wish to formally record that in Paragraph 4 of your response to our offices you state that you are surprised that we shared an IP that you have never mentioned anywhere.

In this regard we attach hereto your own email as directed to our client which clearly state the IP address and as such it is submitted herein that your unlawful actions herein are supported by virtue of your bare denial dated the 18th instant which is contradicted by your own email as attached hereto dated the 17th instant.

Such issues will be further dealt with in litigation should same be necessitated.

We confirm that all of our client's rights are expressly reserved regarding any aspect going forward with regards to litigation herein.
